

iShopChangi x Changi Rewards LoveSG Promotion - Terms & Conditions

Acceptance of Terms and Conditions

By participating in the **iShopChangi x Changi Rewards LoveSG Promotion** ("Promotion"), each participant ("Participant") agrees to be bound by these Terms and Conditions, including any amendments, additions, replacements, modifications and instructions issued by Changi Airport Group (Singapore) Pte. Ltd. ("CAG") from time to time.

Participation in the Campaign constitutes the Participant's full and unconditional agreement to these Terms and Conditions and all decisions made by CAG in relation to the Promotion.

1. Promotion Eligibility

The Promotion is open to all individuals who:

- Are registered members of the Changi Rewards Programme and hold a valid Changi Rewards account ("Eligible Members").
- Comply with the Promotion mechanics and these Terms and Conditions.
- CAG reserves the right to determine the eligibility of any Participant at its sole and absolute discretion.

2. Promotion Period

- The Promotion will run from **1 August 2026 to 31 August 2026** (both dates inclusive), unless otherwise determined by CAG.
- During the Promotion Period, Eligible Members who make a minimum Nett spend of S\$250 on participating LoveSG brands in a single transaction on iShopChangi will receive 6,100 bonus Changi Rewards points ("Bonus Points"), subject to these Terms and Conditions.
 - In calculating the Nett Spend, all discounts given and amounts paid using vouchers (including, but not limited to, Changi e-Voucher(s) and Changi e-Voucher(s) Flexi) shall be excluded, i.e. such amounts are to be excluded when calculating the total qualifying spend in a single receipt.
- The Bonus Points awarded under this promotion are in addition to any regular Changi Rewards points earned for the qualifying transaction.
- Each Eligible Member may receive the Bonus Points once per qualifying transaction during the Promotion Period.
